With Articles of Incorporation issued by the State of Arkansas on 7 January 1992, the Arkansas Jazz Heritage Foundation (which sponsors and maintains the Arkansas Jazz Hall of Fame established in 1994) is an all-volunteer nonprofit dedicated to educating the general public about the historical significance of jazz in Arkansas. Foundation membership is open to any adult (21+) interested in preserving, celebrating, and promoting jazz in Arkansas. The Foundation's educational activities and Hall of Fame inductions are funded entirely by annual dues (\$20 payable 1 July) and donations from individuals. (The Foundation does not share its membership roster or mailing list; however, anyone donating at least \$50/\$100/\$500/\$1000, excluding dues, is recognized at the annual meeting.) Current versions of the Foundation's organizational profile, membership application, Arkansas Jazz Hall of Fame Nomination Form, as well as educational materials (e.g., list of recommended resources, Arkansas Jazz Hall of Fame reference sheet), are available (in print and PDF) from the AJHF Secretary; PDF copies are kept under Downloads tab on AJHF Website https://arjazz.org; scanned copies can be found within the "AJHF: Reference Materials" album under "Photos" on the Foundation's Facebook page, which is linked from a top tab on each page at https://www.arjazz.org. (That AJHF website, which includes a "Search" feature, serves primarily as an archival reference and provides information about Arkansas Jazz Hall of Fame inductees under "Hall of Fame," "Artists," "Downloads," and "Archive.") Each year AJHF members receive a few special e-mails from the AJHF Secretary; otherwise, the Foundation communicates via its Facebook page, where several times each week the AJHF Secretary posts new information/photos/videos related to jazz artists/events/venues in Arkansas.

The Arkansas Jazz Heritage Foundation presented its first Lifetime Achievement Award (subsequently named in his honor) to Art Porter, Sr. in 1993. In 1994 the Foundation established the Arkansas Jazz Hall of Fame with an inaugural group of seven inductees: Herb Ellis; Betty Fowler; Louis Jordan; Art Porter, Sr.; Pharoah Sanders; Charles Thomas; Alphonso Trent. Any nominee not born in Arkansas must have resided in the state for at least ten years. Provided the nomination is supported by a documented history of significant achievement and/or contribution specific to jazz - within or beyond the state of Arkansas - a nominee may be a musician, composer, educator, author, or major contributor to another aspect of jazz.)

The Arkansas Jazz Heritage Foundation now holds Arkansas Jazz Hall of Fame induction ceremonies only in even-numbered years; however, after each annual meeting the Foundation presents a public concert featuring distinguished jazz artists. Except for the annual meeting (open to all members in good standing and held at the concert venue), the Foundation's meetings (including its annual audit) are held in the fourth-floor conference room near the offices of audit partner Cobb and Suskie, Ltd. at One Financial Centre (650 South Shackleford Road, Little Rock, AR 72211) and/or via conference call/link GoToMeeting.com. Operating on a fiscal year which begins 1 July, the Foundation holds regular quarterly meetings for its executive board (officers) and four special meetings for its full board (officers and directors). The location of the Annual Meeting (held at same venue as AJHF Annual Event) will be announced by April 2023.

MEMBERSHIP, DUES, DONATIONS

Foundation membership is open to any adult (21+) interested in preserving, celebrating, and promoting jazz in Arkansas. Annual dues (\$20 payable 1 July) and donations fund ongoing educational activities and upcoming Hall of Fame inductions. The Foundation does not share its membership roster or mailing list; however, any individual donating at least \$50/\$100/\$500/\$1000 (excluding dues) is recognized at the annual meeting/event. The only requirement for general membership is submission of a current application (available from the AJHF Secretary and within the "AJHF: Reference Materials" album under "Photos" on the Foundation's Facebook page) with annual dues, which are waived for the Foundation's incorporators (James Thomson; Blake Hendrix, Attorney-at-Law) and Arkansas Jazz Hall of Fame inductees. There is no penalty for late payment of dues, which are not prorated. No attendance requirement attaches to general membership; however, any member wishing to serve on the board, work on committees, or participate in elections must attend board meetings in Little Rock.
